

### Performance of Egyptian sovereign sukuk (Maturity on February 2026)

Egyptian sovereign Sukuk prices rose to \$102.393 on Thursday (29/05/2025), the highest price during the week, as this coincided with the decision of the United States International Trade Court on Wednesday (28/05/2025) to cancel the 10% tariffs imposed by the US President on goods imported to the American United States.<sup>2</sup> The price of Egypt's sovereign sukuk fell slightly to \$102.273 (30/05/2025) from \$102.283 (23/05/2025), the yield to maturity falling to 7.71% (30/05/2025) from 7.74% (23/05/2025).

The CDS decreased over the last week to 5.39% (29/05/2025) from 5.50% (22/05/2025)<sup>3</sup> This was affected by positive news during the previous period, especially news about attracting investments, the latest of which was what was stated in the Ministry of Finance's monthly financial performance report for May 2025, regarding the Egyptian government's aim to offer shares in 11 companies owned by it within the government's offering program during the current fiscal year 2025-2026, with a value ranging between 3 and 4 billion US dollars.<sup>4</sup>
