Performance of Egyptian sovereign sukuk (Maturity on February 2026)

The Federal Reserve held interest rates on Wednesday (30/07/2025) at 4.25%-4.50% for the fifth time,² the price of Egyptian sovereign sukuk rose to \$ 101.997 (30/07/2025), then fell to \$ 101.815 (01/08/2025) compared to \$ 101.81 (25/07/2025), due to the increase in the annual core Personal Consumption Expenditures Price Index "Measure of inflation" by 2.6% in June 2025 compared to 2.4% in May 2025 released on Thursday (31/07/2025).³

The US dollar exchange rate depreciated against the Egyptian pound to 48.73 Egyptian pounds per US dollar (29/07/2025),⁴ which is the lowest level since the end of October 2024, so CDS fell to 4.54% (30/07/2025) compared to 4.66% (23/07/2025).⁵
